I hereby agree to contract one service for the 2024 breeding season to the stallion *Air Jordans*, AQHA #5929582 for:

Fee Schedule: All fees due at time of booking

- Breeding fee of \$900 payable to Hank and Janet Melsness (Melsness)
- Chute fee of \$350 payable to Goodell Veterinary Clinic (GVC)

The following conditions shall prevail:

1. If for any reason my mare does not settle, I will hold Goodell Veterinary Clinic (GVC) and Stallion Owner (Melsness) harmless. I understand the breeding season opens February 12 and closes July 1.
2. It is agreed that should the stallion die or become unfit for service during the initial breeding season of signing this contract, then this contract shall become null and void, and the Stallion Breeding Fee paid would be refunded less the shipping/reproductive fees.
3. This contract contains a **Live Foal Guarantee**. A live foal is described as a newborn foal which stands and nurses without assistance. In the event the above mare fails to produce a live foal from this breeding, mare owner may rebreed the mare (or a substitute mare mutually agreed upon by mare and stallion owners) during the **following breeding season only** with a rebreed service charge of \$250.00. This guarantee applies only if the mare owner (A) notifies the stallion owner within 72 hours after the time the mare did not produce a live foal, or foal dies; and (B) within 10 days after the mare owners notice, the mare owner provides the stallion owner with a statement from a licensed veterinarian substantiating same. If the Customer fails to return the following season, all fees paid will be forfeited, the right to rebreed cancelled, and Stallion owner released from further obligation of the contract. Breeding fees and Chute fees are non-refundable. For mares that **do not conceive** using cooled semen, a rebreed will be honored the **following breeding season only**. No breeding will be carried over more than one year. If a mare fails to settle for any reason, the mare owner will hold Melsness and GVC harmless.

4. Is this an Embryo Transfer Breeding? Yes/No (Circle one). This contract provides for (1) Breeders Certificate. If multiple embryos are retrieved from the one breeding, an additional Stallion breeding fee will apply per embryo. Melsness must be notified of the number of embryos transferred. If multiple embryos are desired, an additional contract is required for each embryo. If customer decides to freeze an embryo, it is their responsibility to notify when the embryo is frozen and when it is utilized.
5. Stallion Breeders Certificates will be issued when Melsness has been notified that a live foal has been produced and all stallion fees and other expenses have been paid in full. Owner recorded on registration certificate will be recorded on the Breeding Report.
